DROP-IN PRINCESS CRUISES SWEEPSTAKES

OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING.

You hereby agree that your entry into the Club Pilates - Drop-In Princess Cruises Sweepstakes (the "Sweepstakes") is subject to these Official Rules (these "Official Rules"). Sweepstakes void where prohibited by law. The Sweepstakes and your participation therein is subject to all federal, state and local laws, regulations, and ordinances.
